The ENFORCER Gigabit PoE Extenders connects PoE cameras, IP access control, IP telephony, IP speakers/intercoms, or other PoE devices using a single Cat5e or Cat6 cable to extend its data and power range by an additional 328ft (100m). The NR-P401E-TQ supports up to 4 PoE devices.




Overview



Installation:

- Determine the proper location for mounting the extender between the PoE power source and the PoE camera, ensuring that neither cable exceeds 328ft (100m) in length.
- 2. Mount the NR-P101E-TQ using 4 screws (not included) and the mounting tabs.
- For the NR-P401E-TQ, attach the two mounting brackets to the extender, using the 4 included extender bracket mounting screws. Drill holes and attach the extender/bracket assembly to the wall or other desired location using the two wall mounting screws and, if needed, the plastic wall anchors.
- 4. Ensure that power is off to the PoE power source and all PoE devices.
- 5. Connect the cables from the PoE power source to the PoE In port of the extender.
- 6. Connect the cables from the PoE cameras to the PoE Out port of the extender.
- 7. Turn on the PoE power source and wait up to one minute for the devices to start and establish connections.
- 8. Test to ensure that all devices are working properly.

PoE device doesn't function properly

Troubleshooting:

- Ensure that all devices are turned on.
- Ensure that the PoE device is functioning by plugging it directly into the PoE switch, computer, etc.
- Double-check that the cables were connected properly
- Run a continuity test on all wires in the cable
- Equipment at both ends must be at the same link speed, 10BASE-T with 10BASE-T, 100BASE-T with 100BASE-T, etc.
- Replace with a higher-grade cable for better performance
- Ensure that the cable lengths are within the allowable range and consistent with the remote PoE device power consumption, and reduce cable length as needed
- With 1000BASE-T, power consumption is greater, so no more than 2 PoE extenders may be used
- Check that power consumption is within the specifications
